If your application for membership is rejected by the committee:

You may give notice of your intention to appeal within 14 days of being advised of the rejection (rule5(4)).

The Association in a general meeting, no later than the next Annual General Meeting, must confirm or set aside the decision of the committee rejecting your application, after giving you a reasonable opportunity to be heard or to make written representations to the general meeting (rule5(5)).
